DR1. Letter Curling Club

Letter from the Kerry Park Sunday Hangover League. Discussion regarding the reduction of players in their league and the potential impact this could have on their league.

DR3. Kerry Park 15 Passenger Van

The Operations Coordinator presented a report including three options for disposal of the 2004 GMC Savana Van. Options included trade in on a 7 passenger van, sell the vehicle as a capital asset, or selling the vehicle through BC bid or like auction

It was moved and seconded that staff trade the 2004 GMC Savana 15 passenger van for a 7 passenger minivan.

DR4. Short Term Borrowing for the Capital Purchase/ Replacement of the Arena Score Clock

It was moved and seconded that up to a maximum of \$20 000 in short term borrowing for the purchase of a replacement Score Clock be approved and that the loan be paid back over five years under the Liability Under Agreement Section of 175 of the Community Charter

DR6. Willswikk Farms Water Agreement

It was moved and seconded that the Commission authorize the Cowichan Valley Regional District to enter into a renewed three-year Irrigation Water Lease agreement with the option to extend for two additional years with Willswikk Farms (legally described as PID 001-094-512, parcel A (DD 296648-I) Sections 3 and 4 Range 7 Shawnigan District) under the same terms as in original agreement, and authorize the Chair and corporate secretary to sign the agreement.

DR7. Facility Operation Coordinator's Report

The Facility Operations Coordinator reported that the water department is installing an out flow meter and some minor upgrades to potable system. Staff is waiting final report from Water Department on options for improving quality.

The sound system upgrade is complete and training is being provided to groups to train and familiarize them with the new system. User groups are very satisfied with the improved quality of the system. Staff were directed to seek out community groups that could use components of the old system; potentially there are enough pieces that several smaller systems could be pieced together.

DR8. Managers Report

The Manager reported that South Cowichan Recreation participated in the Shakeout 2011 on October 20th at 10:20 am. Participants in the building included fitness and curling groups who took part in this mock drill. The drill went smoothly and participants appreciated being able to take part, and felt this was a beneficial exercise.

The manager reported that 23 staff were recognized from South Cowichan Recreation on October 19th for their service to the CVRD through the CVRD Employee Recognition Program. Pictures were given for service for 5, 10, 15 and 20 years of service.

DR5. Mill Bay Community League Lease Agreement

Doug Higginson excused himself at 6:15pm declaring a conflict of interest.

It was moved and seconded that the Commission authorize the Cowichan Valley Regional District to enter into an additional five-year renewal lease agreement for the Mill Bay Community League property located on Wilkinson Road with a lease increase of approximately 7% per year for five years, and to authorize the chair and corporate secretary to sign the agreement.
