It was moved and seconded that the minutes of the September 20, 2012, Environment Commission meeting be adopted as presented.

DELEGATION

Randy Alexander, Baljeet Mann, John Deniseger, Ministry of Environment (MoE) representatives, gave a presentation on water, Cowichan Watersheds, and the cumulative effects of land use to our water quality. MoE is currently working with other partners on a 2½ year monitoring program from Cowichan Lake to Cowichan Bay and are now working towards cumulative solutions. Ms. Mann discussed the Liquid Waste Management Plan (LWMP) (1999). The plan is due to be reviewed and updated. Now is the time for revisions. The MoE letter of 2011 to the CVRD was not responded to. Brian Dennison, General Manager, E&E responded. New environmental quality provisions now, looking at cumulative impacts. Future – planning for what we want in 30 years. Should JUB be moved was a question brought forward. Getting rid of pollutions and making environmental boundaries are priorities. Discussion ensued. The role of this commission is to be an advisory committee. A sub-committee should be formed to work on the Liquid Waste Management Plan.

ACTION: Environment Manager to request MoE to provide to the Environment Commission a job description or best practices for the monitoring committee on the Liquid Waste Management Plan. Request the PowerPoint of this evening to be sent for our referencing. Presentation to the Board will be done.

Suggestion that the commission studies the Central Sector Liquid Waste Management Plan thoroughly and asks the GM, E&E, for insight into how the Environment Commission can participate. Also ask the CVRD CAO, Chair Hutchins and GM of E&E to meet and discuss where we expect to be in two years.

The heat pump revision will be withdrawn. It may be a year before the provincial government might discuss this work.

Green Building Policy discussion - tabled to next meeting

Economic Development Invitation – meeting arranged for November.

Water flow in Cowichan River -

- i. Community support and leadership shown for the ads re drought. It became an opportunity for community groups to work together. Phenomenal media coverage and interest as far afield as Ottawa and Europe.
- ii. Log jam and gravel removal has been done along the Cowichan River. Dikes are now being built. Water is flowing again and fish are moving up the river. Data on numbers of fish can be provided if desired.

Minister will meet and tour the river and things are unfolding. We will revert to rule curve at the moment. CVRD may take out an additional conservation water licence.
