3) Director's Update

- i) Ministry of Environment is expected to give approval for the SIA application shortly.
- ii) CVRD Budget is under review. Current draft shows an 8% increase for Area B. The March 31 CVRD Board meeting will be important to finalizing the budget package.

4) New Business

- i) Knight Application (2-B-12ALR)
 - Applicant reviewed the rationale for the application and the request for division along Shawnigan Mill-Bay Road. Family inheritance requirements motivate the application for subdivision.
 - APC discussion on the application followed and included question about access to the property and building structures that may be required for agricultural use.

- An error is noted in the application: under Property Context the application shows "6.4 hectares" and it should be 9.8 hectares.
- Motion Carried: APC has no objection to the subdivision provided that the property remains viable for agricultural use; moved by Ian Caesar, seconded by Steve McLeod.
- ii) Craig Partridge and Ronald Sharpe Application (2-B-11RS)
 - Area Director Fraser overviewed the advisory role of the Ecological Design Panel as a group of domain experts providing advice in their respective domains to the APC when requested by the APC.
 - Application as presented does not meet current or proposed zoning requirements.
 - APC Discussion on the economic and ecologic viability of a development approach that could offer more water shed land control and benefits longer term.
 - Application carried forward for review at next month's meeting.
 - A development site visit is scheduled for Sunday March 10 at 12:30pm.
