Don Herriott provided an update on past Joint APC applications most of which were dealing with OCP or zoning amendments in Shawnigan Lake.

Director Giles provided the APC with an update on the following topics:

- 1) Zoning Bylaw 3520
 - Mill Bay/Cobble Hill only
 - Shawnigan remained with bylaw 985 as amended
 - General discussion on SIA, Dirty Dirt and Gravel Pits on Forestry Land
- 2) Fisher Road Recycling
 - new monitoring well drilled south of the tomato farm... nitrate levels normal
 - contracts obtained from Saanich/Oak Bay which puts FRR over flow through capacity
 - FRH taking legal action against CVRD challenging the right to regulate flow through
- 3) Balme Ayr Farm Gravel Extraction Application
 - no decision
 - ALC has visited the site

- 4) Village Sewer System
 - recycled water system should be operational in time for the 2014 irrigation season
- 5) Budgets & taxation
 - ongoing
 - expected this year it will be a highly political process because it is an election year
- 6) Wage freeze in 2014 for the board and senior staff
 - committee formed
 - Chair Phil Kent, Mayor of City of Duncan
 - I am a member of the Committee
- 7) New Hospital Site
 - criteria endorsed
 - looking for acreage to hold for future construction
 - CVRHD is taxing to raise significant funds to go toward a new hospital.

A discussion took place on the above items and the presentation by Don Herriott. Questions from APC members were asked and answered.
