Rezoning Application 1-A-14RS Mill Bay Baptist Fellowship The Chair asked for self-introductions.

The Chair then asked the applicant if they would like to speak to the Rezoning Application. Mr. Burdge gave an overview of the application. There is no Baptist Church in the area and the current facility being used (Mill Bay Community Hall) is becoming crowded. The Congregation would like to have their own Church. The lot that they have purchased is zoned Forestry which they would like to have changed to Public Use. He advised that the lot does not contain any significant trees. It is their intention to also build facilities that would provide such community assets as community garden, day care and a caretaker's residence.

Q. When would the facility be built?

A. There is no specific time frame but not too far in the future.

Q. Have you approached the neighbours?

A. Yes, and they seem to be supportive. There are no residences close by.

Q. Director Walker was asked if the intended use was appropriate based on the OCP and if there were any concerns from staff? A. Yes the use is consistent with the OCP and the staff has no concerns.

Q. Are there plans for a substantive subsidized housing and food kitchen facility? A. No, there may be a small facility but it would not be large. As well, any development would require a Development Permit.
