- e) I am not entitled to register as a resident elector in Electoral Area _____;
- f) I have not registered as a non-resident property elector in relation to any other parcel of real property in Electoral Area _____;
- g) I have received the written consent of the majority of individuals registered as owners of the real property to be registered as the non-resident property elector for this property (if applicable); and
- h) I am not disqualified by the *Local Government Act* or any other enactment from voting or am not otherwise disqualified by law.

BC Assessments and Property Tax Notices will not be accepted as they do not accurately reflect if there is more than 1 (one) owner per parcel. Copies can be obtained from your local Government Agent's office or Land Titles office.

READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING APPLICATION FORM <u>The form must be completed in ink</u>. Pencil is not acceptable.

- (1) Applicants must meet the requirements in this section in order to register as a Non-Resident Property Elector.
- (2) Print applicant's surname and given names.
- (3) Print the street address or legal description of the real property in relation to which you are registering.
- (4) Print mailing address of applicant.
- (5) This information is required pursuant to the Local Government Act.
- (6) Applicant must sign here.
- (7) A person who was present when the applicant signed his/her name must sign here.
- (8) Address of the witness here, except if Election Official.
- (9) You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering under this section indicates that there is more than one individual who is the registered owner of the real property. The person registering must do so with the written consent of those individuals who, together with the person registering, are a majority of those individuals.
- (10) If registering at the time of voting, applicants must provide at least 2 pieces of identification that prove who they are, at least one must contain the applicant's signature.
- (11) Pursuant to Section 70(4)(a), the applicant must include a copy of the "Certificate of Title" in relation to the real property or a copy of a "Title Search" from Land Titles as proof of eligibility to register as a non-resident property elector.
