A grant application in the amount of up to \$30,000 will be submitted to Canadian Heritage's Canada Cultural Spaces Fund for lighting and art gallery upgrades in the Cowichan Performing Arts Centre (CPAC). This grant offers a great opportunity for CPAC to upgrade and extend the lighting and hanging system for the lobby art gallery, as well as adding improved lighting to the stairwell and totem.

Regional Water Conservation and Stewardship Program

The COTW is recommending that staff implement the educational component of a regional water conservation and stewardship program as described in the May 14, 2025, Staff Report from the Environmental Services Division; and that staff develop an incentive program for water conservation and stewardship as part of the 2026 budget process.

Baseline Funding from Canada Public Transit Fund

A positive update to the Committee regarding a recent letter received from the Minister of Housing, Infrastructure and Communities with respect to transit funding that will be allocated to the Cowichan Valley Regional Transit System commencing in 2026, through the Baseline Funding stream of the Canada Public Transit Fund (CPTF).

CVRD has been advised that it can benefit from an allocation of up to \$5,152,880 over ten (10) years, beginning in 2026. It is anticipated that the funding could potentially be applied beginning on April 1, 2026 which is the start of the BC Transit fiscal year. Once CVRD staff receive the BC Transit three (3) year budget forecast and information on the estimated lease fees for the replacement CVX and SVX buses, staff will update the Committee with these costs.



Emergency Management Cowichan (EMC), on behalf of the CVRD, the Town of Ladysmith and the City of Duncan, have launched a **FireSmart Rebate program** to support homeowners in performing Firesmart activities on residential properties.

The Cowichan Regional FireSmart Resiliency Program is designed to help homeowners and communities reduce the risk of wildfire damage. In 2023-2024, more than 200 homes were assessed in the Cowichan region. Recommendations in FireSmart home assessments can now be funded for eligible applicants under this rebate program.

2025 Cowichan Emergency Warming Centre helps unhoused community members over winter thanks to EMC and community support

At the May 14, 2025 COTW, the CVRD Community Services Dept. / Emergency Management Cowichan (EMC) spoke to a report on the Cowichan Emergency Warming Centre's 2025 Winter season. Unhoused people in our communities is a region wide issue and concern in the CVRD. There are people in all our communities, large and small, who are struggling with being unhoused. Some also suffer from addiction and other mental health challenges.

The 2025 winter season marked Cowichan's second year without a BC Housing-funded Temporary Winter Shelter or Extreme Weather Response Shelter. Based on a siting analysis completed for the CVRD following the 2024 winter season, and a decision to relocate an EWC away from the Cowichan Community Centre (CCC), the 2025 EWC was located on leased private land behind the Ramada Inn (140 Trans Canada HWY in Duncan).

EMC opened the Emergency Warming Centre (EWC) between the months of November 15, 2024 and March 31, 2025, and it was operational on nights when local weather criteria was met. Within that period, Lookout Housing and Health Society (LHHS) reported that the EWC was open 103 nights and 1772 clients served. LHHS does not record whether a client is a repeat or first-time EWC user; "clients served" represents personnights of warming rather than 1772 individuals.

EMC has heard from RCMP and Duncan Bylaw that the location of the 2025 EWC did not create significant additional call volume in the neighbourhood. It is unknown at this time if this site would be available in future years.

Thank you for the gracious support of all residents in the Cowichan area. How we treat are most vulnerable population speaks to how we function as a whole community. Having compassion, empathy and patience for those experiencing homelessness while future winter shelter options and funding are sought is a highly valued contribution.

Cowichan Residents Express Satisfaction with CVRD Services

The results of the most recent region-wide survey for residents of the Cowichan Valley Regional District (CVRD) show that the vast majority of residents continue to be highly satisfied with their quality of life in the region.

Beginning February 5, 2025, a total of 412 residents participated in a statistically valid survey administered by Leger to determine satisfaction with the many services delivered by the CVRD.

Concurrently, an identical online survey was conducted that received 667 contributions. A majority of residents (88%) rated their overall quality of life as either good (56%) or very good (32%). Satisfaction with parks and trails was ranked second-highest of all the services polled, and was identified regionally as the most important service delivered by the CVRD. Residents identified unhoused peoples as the single most important issue facing the region (22%), followed by housing availability and affordability (11%).

"We appreciate the time that residents took to participate in this important community survey, and this comprehensive feedback clearly shows us where we can continue to improve on our service delivery," said Kate Segall, Chair of the Cowichan Valley Regional District Board of Directors.

"This is excellent data that will help us with our developing future budgets and for our staff to prioritize their work and determine areas of focus."

Concurrent to the statistically valid survey, some 667 residents opted to complete an open version of the survey online.
