The Cowichan Valley Regional District will hold a Public Hearing on October 20, 2025, at 5:00 p.m., to consider CVRD Bylaw No. 4373 - Cowichan Valley Regional District Official Community Plan for the Electoral Areas Bylaw, 2024. This Public Hearing will be conducted in a hybrid format: persons who believe their interest in property is affected by the proposed bylaw may participate online, by phone, or in person, or may provide written submissions.

PURPOSE OF THE PROPOSED BYLAW

CVRD Bylaw No. 4373 – Cowichan Valley Regional District Official Community Plan for the Electoral Areas Bylaw, 2024

The purpose of Official Community Plan Bylaw No. 4373, 2024 is to adopt an Official Community Plan (OCP) that applies to all electoral areas within the Regional District. The OCP is a modernized version of the harmonized OCP for all electoral areas that was adopted by Bylaw No. 4270 in 2021, and includes the following schedules:

Schedule A – Official Community Plan for the Electoral Areas

Schedule C – Development Permit Areas Schedule D – Agricultural Land Maps Schedule E – Fire Protection Maps Schedule F – First Nations Reserves Maps

Schedule G – Growth Containment Boundaries and Growth Area Maps

Schedule H – Heritage Designation Map Schedule J – Sand and Gravel Deposits Maps Schedule L – Land Use Designations Maps Schedule M – Marine Area Map

Schedule O – Floodplain and Dam Maps Schedule P – Terrestrial Parks Maps Schedule S – Service Areas Maps

Schedule T – Transportation and Major Roads Maps Schedule U – Development Permit Area Maps

Schedule B Local Area Plans are still in development and will be included in the OCP at a later date anticipated to be winter 2025-2026.
