HERITAGE EVALUATION

Heritage value may be defined as aesthetic, historic, scientific, cultural, social or spiritual importance or significance for past, present or future generations.

Significant buildings, structures, sites, landscape features or other resources may have heritage value because they:

- ❑ Illustrate achievement in concept and design, technology and/or planning, or a significant stage in the development of the community, region, province or nation;
- ❑ Are associated with events that have contributed to patterns of history at the local, regional, provincial or national levels;
- ❑ Are associated with the lives of persons of historical importance at the local, regional, provincial or national levels;
- ❑ Illustrate or symbolize in whole or in part a cultural tradition, way of life, or ideas important in the development of the community, region, province or nation.

CRITERIA

Architectural History:

- ❑ **Style/Type:** Does the building or structure represent a significant historical period; or is it associated with a significant commercial, agricultural, industrial, institutional, or transportation activity?
- ❑ **Design:** Does the building or structure have notable or special attributes of an aesthetic or functional nature (massing, proportion, materials, detail, fenestration, ornamentation, artwork, or functional layout)?
- ❑ **Construction:** Is the building or structure constructed of unique or uncommon materials, or is it constructed using an early or innovative method of construction?
- ❑ Did the architect, designer, engineer and/or builder make a significant professional contribution to the community, region, province or nation?

Cultural History:

- ❑ **Historical Association:** Does the building, structure, site, or landscape feature have a direct association with a person, group, institution, event or activity that is of historical significance to the community, region, province or nation?
- ❑ **Historical Pattern:** Is the building, structure, site or landscape feature associated with broad patterns of local area history, including settlement or development patterns, early or important transportation routes, ecological or geographic change, significant landforms, or social, political or economic trends?

Context:

- ❑ **Landscape/Site:** Are there intact historical landscapes or landscape features associated with the building, structure, site or landscape feature; or a notable historical relationship between the heritage resource and the immediate environment, including original native trees and topographical features; or a notable use of landscaping in conjunction with an existing building or structure?
- ❑ **Neighbourhood:** Is the building compatible with neighbouring buildings?
- ❑ **Visual/Symbolic Importance:** Is the building, structure, site or landscape feature an important landmark or does it have strong value to the community, local area or neighbourhood?

Integrity:

- ❑ Has the building, structure, site or landscape feature been modified or altered since its original construction?
