- 2. That the Regional Sport Tourism Select Committee guideline to consider bid submissions every four to six years to host multi-sport games in the Cowichan Region be confirmed.

BACKGROUND

In March 2018, municipalities and regional districts received an invitation to bid on the 2020, 2021, or 2022 55+ BC Games. The Municipality of North Cowichan referred the invitation to the CVRD Board, who reviewed the item at the March 14, 2018 meeting. The Board referred the item to staff for a report.

Further Background

In 2014, the Board established a Regional Sport Tourism Select Committee to recommend appropriate sport tourism activities and associated budget.

On July 30, 2014 the Board approved the recommended establishment of a sport tourism section in the Economic Development function, a list of activities, and associated budget. The Board at that time also directed that a report be provided prior to approval of the CVRD's 2017 Budget to address whether the following priorities could be included in the sport tourism mandate:

- Provide specific resources to attract and host a multi-sport games in the Cowichan Region every four to six years.
- Develop a specific sport tourism brand, similar to Kamloops (Tournament Capital of Canada) or Abbotsford (Sport Town Canada).
- Establish a specific budget for bids for events.
- Establish a program to assist existing community organizations hosting provincial, regional, national, or international events.

The minutes of that section of the July 30, 2014 CVRD Board meeting are provided for reference in Attachment A.

The sport tourism initiative has now established web based databases for Cowichan Region venues, sport organization contact lists, and a regional schedule of events. A community event equipment inventory has been established for use by community organizations. A sport tourism guide to assist in finding facilities and local attractions can be found throughout the region. A funding program of

\$30,000 has been established to assist community organizations hosting provincial, regional, national, or international single sport events.

ANALYSIS

Of 100 relevant sport tourism questions put to them, the Regional Sport Tourism Select Committee in 2014 considered the question of "How often should the Cowichan Valley host major multisport games such as the BC Games or NAIG?"

- 1. Every year
- 2. Within every three years
- 3. Every four to six years
- 4. Every seven to ten years
- 5. Less than once per decade

The majority of the committee chose number 3, every four to six years.

Further, the Regional Sport Tourism Select Committee in 2014 considered the question of "How often can the Cowichan Valley count on being able to get the commitment of more than 1,000 volunteers for a large event (BC Winter Games, BC Summer Games, NAIG)?"

- 1. Every year
- 2. Within every three years
- 3. Every four to six years
- 4. Every seven to ten years
- 5. Less than once per decade

Again, the majority of the committee chose number 3 every four to six years.

This direction still remains with staff, that the region's capacity to host an event of this size is every four to six years.

The Cowichan Region will be hosting the Cowichan 2018 BC Summer Games in July 2018. The community is currently extremely busy preparing for that event, and there are minimal staff resources available for bid preparation. The invitation to bid for the 55+ BC Games is for two, three, or four years after the Cowichan 2018 BC Summer Games. An invitation is anticipated in the future to bid for the 2023, 2024, 2025 55+ BC Senior Games, which would hold more appeal to staff with their current limited resources.

Although the 55+ BC Games is an excellent event, another factor to consider is whether the 55+ BC Games is the best choice for Cowichan at that time. The Regional Sport Tourism Select Committee considered which event in Cowichan's history had the greatest combination of impacts (economic, social, facilities, community pride, and volunteer level) on the Cowichan Valley, and the majority chose North American Indigenous Games (NAIG), 2008. The 2005 BC Seniors Games held in Cowichan also received support from the committee, but not to the level of NAIG, 2008.

There are also opportunities to host events we have not hosted before, such as provincial Special Olympics, or national multi-sport games. Commencing in 2019, staff recommend investigating bids for multi-sport opportunities in 2023 and beyond.

FINANCIAL CONSIDERATIONS

A multi-sport games typically has financial support from outside of the community, which may be in the form of grants from senior levels of government, or other grants. Participants may pay fees. Local businesses pay for sponsorships.

Local government typically provides cash and in kind support (free rental of venues, etc.). The 55+ BC Games requires local government financial support of \$60,000, and in kind support estimated at \$55,000.

Multi-sport games create economic impact for the community. The 55+ BC Games bid package outlines that the direct economic impact of the Richmond Seniors Games in 2009 was \$2.1 million, and the Langley BC Seniors Games in 2014 was \$3.1 million.

The other financial consideration is that multi-sport games often leave a financial legacy. Coquitlam in 2016 reported a legacy of \$60,000.

COMMUNICATION CONSIDERATIONS

The BC Seniors Games Society will be advised if Cowichan bids on the 2020, 2021, or 2022 55+ Games.
