#### a. Communications with First Nation Stakeholders

The Chair reported that the consultation with First Nation stakeholders is in progress and that a report of communications will be provided.

# b. Open House Report

The open house held April 25, 2018 was attended by 19 people. An additional two open houses are scheduled during the planning process.

#### c. Letter from VIRWIC

A letter was received from Vancouver Island Recycling & Waste Industry Coalition regarding adequate representation on the PAC from private businesses. The Chair reported that although attempts were made to recruit representatives only two responses were received and both of those respondents are Committee members.

# d. Survey Report

Surveys were submitted by 118 participants on the CVRD website and PlaceSpeak. A majority of responses reported being mostly satisfied with garbage collection, recycling collection and public drop off depots. Less than half of respondents reported satisfaction with communication and education. The top 3 values were waste reduction, diversion and environmental protection. Preliminary comments included frustration with which materials can be recycled and lack of collection for bulky items, yard waste, single-use items, film plastic and glass.

#### a. Workshop Report

Nine Committee members participated in the webinar held May 3, 2018 that considered options and successes, and promoted information sharing.

## Solid Waste Management Plan Presentation

Tetra Tech consultants provided the PowerPoint presentation 'CVRD Solid Waste Management Plan Update'.

## a. Recap of Process

This meeting objectives include setting guiding principles, creating a preliminary shortlist of options and considering goals.

### b. Guiding Principles – Summary of Feedback

Ministry SWMP guiding principles were presented as a template to adopt these as CVRD SWMP guiding principles with suggested modifications to fourth principle, 'Support polluter and user pay approaches and manage incentives to maximize behavior outcomes.' In order to incorporate elements of education to influence systems change, the suggested language for the fourth principle is 'Support structural and systemic changes (e.g. polluter and user pay approaches) and corresponding behavior change programs to optimize system changes and promote principles one and two.'

#### c. Goal for SWMP

Three suggested goals for the CVRD SWMP were presented as:

- 1. Adopt zero waste
- 2. Target regional disposal rate of 180 to 300 kg. per capita by 2030
- 3. Target 90% of all businesses and residents have minimum service levels (e.g. recycling and organics collection) by 2025.

The Committee members broke into partners to discuss the goals and record feedback on worksheets. Members discussed and shared their feedback with the group.

# d. Feedback on Options

The Committee was presented with eight options under the reduce, reuse, recycle category, four under recovery and residuals management, and three under operational improvements, for consideration and were asked to identify the most important options. Members were asked to vote on options that they felt most strongly about during a feedback exercise.

# e. Presentation of Preliminary Shortlist

A preliminary shortlist of options was presented indicating how each weighted in conjunction with the draft guiding principles.

## f. Summary of PAC Feedback on Options

Results of options 'dotmocracy' were tallied and divided into 'go', 'no-go' and 'revisit' categories.
