OPERATIONS

Coast Environmental Ltd. operating practices are, as follows:

- Demolition, roofing and wood waste is transferred to an approved recycling facility after sorting and consolidating any recoverable and recyclable products. Landfilling of non-recyclable material may be necessary from time to time.
- Municipal Solid Waste is transferred to an approved landfill for disposal
- Drywall is transferred to an approved facility for recycling
- · Concrete/brick/rubble are transported to an approved facility for recycling or disposal
- Yard, garden, and food waste is transferred to an approved composting facility

The anticipated change in traffic entering and exiting the site will be, as follows:

Current traffic: 3 - 4 truck/trailer combinations, 10 - 30 self-tipping vehicles, 10 - 50 passenger vehicles (operators)

Anticipated traffic: 3 - 6 truck/trailer combinations, 10 - 30 self -tipping vehicles, 20 - 70 passenger vehicles (operators)

Public Drop-off hours are from 7:00 am - 5:00 pm Monday - Sunday

Operating hours are from 7:00 am - 7:00 pm Monday - Sunday.
